Project Duration

Dates: 1st to 6th May 2019

Location: Vila Nova de Tazem, Portugal

Travel days: 30th of April and 7th of May 2019

Coming later or leaving earlier is not allowed, in which, if you are in one of these situations, we'll not reimburse you.

You can extend your travel up to **3** days, although these days will not be supported by the project.



- \rightarrow We do not have public transport from Porto or Lisbon to Vila Nova de Tazem.
- → To reach Vila Nova de Tazem, there are buses to nearby cities such as: Viseu, Gouveia or Seia, or trains to: Mangualde.
- → From these cities to Vila Nova de Tazem, Reencontro will be in charge of the transport.
- → In case that more than 50% of the group arrives to the <u>Porto airport</u>, Reencontro will arrange a common bus to pick everyone. To ensure transportantion, when transferring the money to pay for travel, will be captive 10% of the total amount up to the maximum amount of 30 euros per person.
- \rightarrow In this case, the bus would leave Porto at **6 p.m.**, meaning all flights should arrive before.
- → For us to be able to provide dinner, everyone should arrive to Vila Nova de Tazem before 8 p.m. on 30th of April.
